 you may lose your balance and fall from your board onto a shallow sandbank, rocks or reef;
 you may be dumped by a wave onto a shallow sandbank, rocks or reef;

you may be caught in a rip and dragged out to sea or into an area where the waves are breaking with high impact or onto a shallow reef, sandbank, rocks or a headland;
 you may be exposed to rapid and adverse changes in weather, ocean and wave conditions; and/or
 you may be stung or bitten by an ocean creature, such as a bluebottle jellyfish, sea snake, stone fish, stingray or shark,
 and as a result you may aggravate an existing injury (especially shoulder injuries) or suffer serious injury (such as cuts (which may become infected), broken bones, fractures or breaks to the spine or skull), disease, paraplegia, quadriplegia or death (including by drowning).
