RISK WARNING, RELEASE AND EXCLUSION OF LEGAL LIABILITY

Surfing can be an enjoyable and exciting activity. However, like many recreational activities that require physical exertion, surfing carries with it the risk of physical injury.

The risks associated with surfing include the following:

you may be exposed to cold water (and possibly polluted water) and the sun for a long period of time;

you will be physically exerting yourself in ways you may or may not be accustomed;

you may collide with another surfer (or other ocean-user) or his or her (or your own) board;

you may collide with some other water-craft (including being run over by a jet ski or boat (including if it gets caught by a breaking wave));

you may be driving, or be a passenger or be towed by, a powerful, high speed jetski or boat that may collide with you, another surfer, other watercraft or be

dumped onto a shallow sandbank or reef; you may lose your balance and fall from your board onto a shallow sandbank or reef;

you may be dumped by a wave onto a shallow sandbank or reef; you may be caught in a rip and dragged out to sea or into an area where the waves are breaking with high

impact or onto rocks or a headland; traveling to, along and from the surfing venue, including air travel; you may be exposed to rapid and adverse changes in weather, ocean

and wave conditions; and/or you may be stung or bitten by an ocean creature, such as a bluebottle jellyfish, stingray or shark, and as a result you may aggravate an existing

injury (especially shoulder injuries) or suffer serious injury, disease or death (including by drowning). You should ensure that you wear an appropriate wetsuit or rash shirt

(in the hotter months), apply maximum protection sun-block cream on all exposed skin.

By participating in surfing activities and/or equipment provided by GSM (Operations) Pty Ltd, its related bodies corporate and any other person in conjunction with whom they conduct the Burleigh Point single fin festival (Event) or provide any services, including Burleigh Heads Boardriders Inc (Event Organisers) and Surfing Queensland either at this time or in the future, you agree:

to comply promptly with all directions given to you by the Event Organisers any of their employees or agents or by any surf lifesavers on duty;

that you participate at your own risk; that the agreement for services provided to you by Event Organisers hereby totally excludes any liability

that results from breach of any implied or express warranty that the services of the Event Organisers will be rendered with due care and skill and excludes

any implied or express warranty and any liability for their breach that any equipment provided by the Event Organisers in connection with the surfing

activities or separately will be fit for the purpose for which they are supplied; the Event Organisers have no liability to you for personal injury, disease or

death arising from the services and/or equipment that the Event Organisers provides to you; to irrevocably and unconditionally releases and forever

discharges the Event Organisers and their officers, employees and agents from all present and future claims (including claims in contract, tort or statute)

which you may have against them; and acknowledges that the Event Organisers may plead this risk warning, release and exclusion of legal liability as a bar

to any claim or proceeding that arises out of or relates to any matter referred to in it. If a court determines that any part of this risk warning, release and

exclusion of legal liability is invalid or unenforceable then they are to be severed from the rest and all other parts are to be given full legal force and effect.
